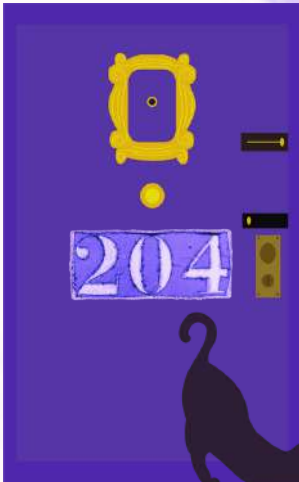

President's Message

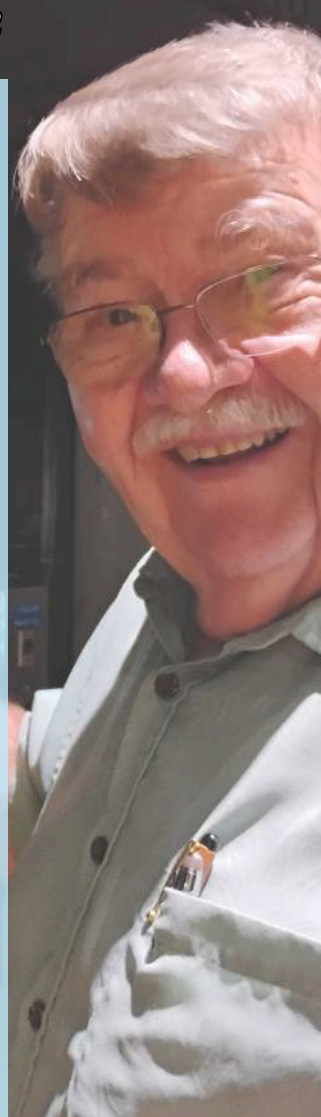
